Wills

A will sets out your wishes on what should happen after you die. A will ensures that loved ones are provided for after your death and helps avoid disputes. It is important to make a will to guarantee that those you want to leave money or possessions to benefit in accordance to your wishes.

Contesting a Will

Wills sometimes cause friction among loved ones and sometimes it may be necessary to contest a will. This may be when someone feels that they have been left out of a will unfairly, have not received a fair proportion of the estate, or the will fails to take into account their entitlement under inheritance law. It may also be that the deceased made a will as a result of external pressure from another party.

Probate

Probate is the legal process of administering a will so that beneficiaries can receive their assets with any due taxes being paid before the estate is distributed. The five basic stages of the probate process include collecting assets and monies, valuing all assets, applying for probate, distributing the bequests in the will and drawing up accounts showing how the estate was distributed, which are then sent to the beneficiaries.

Probate without a Will (Intestacy)

If there is no will or a will cannot be found, the law will decide on the distribution of an estate unless a close family member applies to the court to allow them to act as the deceased's personal representative.

The personal representative can appoint a legal representative to help with the administration of the estate, our solicitors have extensive experience acting in such situations.

Lasting Power of Attorney

Lasting Power of Attorney (LPA) is a legal document made between a donor and the person(s) they appoint as their attorney(s) to manage their affairs.

An LPA can be made by anyone aged 18 or over who has the mental capacity to act for themselves. A donor can choose different attorneys for different LPAs.

There are two different types of LPA which can be made relating to:

Management of finances and property
 Health and welfare of the donor

It is advisable to consider appointing a solicitor to help manage finances and advise on care decisions to alleviate the burden of making decisions from family members who may not know about access to care, financial or property law.
